He sold that business to Brickman Group in 2004 and successfully integrated the existing team into Brickman.

With Brickman, Joel's responsibilities included leadership and management of a \$300 million business unit that earned over 20% EBIDTA. He was directly responsible for operations in Ohio, Michigan, Kentucky, Tennessee, Indiana, Illinois, Minnesota, Wisconsin and western Pennsylvania markets which included 36 individual business branches.

In 2013, Brickman merged with Valley Crest Landscape to form BrightView, the largest commercial landscape firm in the industry. Joel remained with BrightView until 2015, when he formed New Growth Strategies, LLC, a consulting firm providing transformative strategic and operational consulting services for landscape contractors and private equity investors.

Joel was retained by private equity firm ClearLight Partners in 2017 to lead a consolidation effort in the landscape industry, which led him to become the CEO of the platform acquisition, Moore Landscapes Inc., located in Chicago. Known for his highly effective team building and individual coaching, Joel guided Moore Landscapes through rapid growth, transition and advancement by implementing best practices and structuring processes to maximize results.

Joel's expertise includes strategic direction, sales growth, operations management, and mergers and acquisition negotiation and operational integration.
